**RELEASE OF LIABILITY AND ASSUMPTION OF RISK**

In consideration of the services of The Circuit Inc., its agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "TC"), I hereby agree to release and discharge TC, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that climbing is a highly dangerous activity, and that the activities involved in the use of any of TC's services or facilities, at this location and all other locations, both climbing and non-climbing related, entail significant risks, both known and unknown, which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I expressly agree and promise to accept and assume all of the risks existing in these activities, both known and unknown, whether caused or alleged to be caused by the negligent acts or omissions of TC.
