



HILLSBORO ITF BIKEPARK POLICIES

Hillsboro ITF Bikepark is a secure, indoor, bike commuting facility. Amenities include 40 bike racks, day-use lockers, restrooms, showers and changing rooms, along with free use of air pumps and several repair tools. . The Bikepark is a locked facility and members can access the space 24/7 with an electronic access key fob. The facility is monitored by 24/7 video surveillance and includes panic devices inside the shower rooms and restrooms.

Use of the Hillsboro ITF Bikepark is limited to members only. To maintain the Bikepark for the benefit of all members, the following polices govern the use of the facility. Pursuant to your membership application, a violation of any of these policies may result in termination of your membership.

- All amenities in the facility are provided on a first come, first served basis. Members must use their own locks to secure their bikes to the rack and their belongings in a locker. Bike locks and other personal property need to be removed from the bike rack with the bike.
 - You may only park one bike at a time in the facility. To ensure that the Bikepark is used for bike commuting and not storage and to keep bike hooks available for other users, bikes may not be left longer than 48 hours without being used. Any bike left at the facility that is not used or accessed at least once every 7 days, will be considered to be abandoned.
 - A member may not use more than one locker at a time. Lockers are intended for storage of items necessary for regular bike commuting. Lockers are not to be used for long-term storage.
 - Only the registered member is allowed to use the key fob to gain access to the facility. Under no circumstances is anyone else permitted to use another's key fob. Members are responsible for keeping their access fob secure and accounted for.
 - "Tailgating" is not allowed. Each member must present his or her own fob to the reader for access, even if another member is entering and the door is open. Following another member in or allowing someone to follow you in is NOT allowed.
 - Use of the showers is limited to one individual at a time. You must respect the privacy of other members and should not attempt to enter a shower area when it is in use by another member.
 - Proper attire inside the Bikepark is required. Members are expected to change clothes only in the changing rooms or shower area.

- Sleeping within the Bikepark is prohibited. The Bikepark is established to be used for bike commuting, and sleeping within the facility is inconsistent with this purpose.
- Smoking and the use of illegal drugs and alcohol is prohibited in the Bikepark.
- Animals (other than service animals) are prohibited within the Bikepark.
- The use of sound amplification equipment or sound producing equipment other than personal listening devices audible only to the person using the device is prohibited within the Bikepark.
- Members may not engage in cooking activities within the Bikepark. Eating within the Bikepark is generally discouraged. It is recognized that members may at times consume a snack while within the facility. Members are expected to clean up and properly dispose of any trash or food remnants that result from such activities.
- Members may not possess any hazardous substance or destructive device that may cause personal injury or property damage including, but not limited to, fireworks, within the Bikepark.
- No weapons of any kind shall be stored within the Bikepark. Unless otherwise authorized by law, members may not possess any weapons within the Bikepark.
- Members may not engage in a commercial pursuit, solicit for or conduct any business, including selling or attempting to sell any merchandise or services, or solicit for a charitable contribution within the Bikepark.
- Members must treat other users of the Bikepark with respect and courtesy. No harassing or intimidating behavior is permitted.
- Members may not engage in any other activity within the Bikepark that creates a danger of personal injury or property damage.
- Any use of the Bikepark which is not in the best interests of the members, or is in violation of any laws of the United States, the State of Oregon, the County of Washington, or the City of Hillsboro is prohibited.
- Any person, whose conduct is reasonably believed by representatives of the Operator to be disorderly, as defined by Oregon Statute ORS 166.025, or otherwise in violation of any laws, may be refused entrance or may be immediately ejected from the Bikepark.
